RESOLUTIONS

Information on the Resolutions is set out below:

1. Approval of Annual Financial Report (Resolution 1)

Resolution 1 is proposed to receive the Company's report of the Directors and the audited financial statements for the year ended 31 December 2011.

2. Approval of Directors' remuneration report (Resolution 2)

Resolution 2 is proposed to seek Shareholder approval of the Directors' Remuneration Report. It is mandatory for all listed companies to put their report on Directors' remuneration to an advisory Shareholder vote. As the vote is advisory it does not affect the actual remuneration paid to any individual Director. The Directors' Remuneration Report is set out on pages 33 to 34 in the Annual Financial Report.

3. Directors (Resolutions 3 to 9 inclusive)

- 3.1 Resolutions 3 to 9 (inclusive) deal with the re-election of Directors.
- 3.2 The Articles of Association require one third of the current Directors to retire by rotation at every Annual General Meeting. 4. Reappointment of auditors (Resolution 10)

Resolution 10 proposes that Ernst & Young LLP be reappointed as the Company's auditors to hold office until the next annual general meeting of the Company and that the Directors be authorised to fix their remuneration.

5. Renewal of Directors' authority to allot shares (Resolution 11)

5.1 Resolution 11 deals with the Directors' authority to allot relevant securities of the Company in accordance with section 551 of the 2006 Act. The authority given to the Directors at the 2011 Annual General Meeting to allot shares expires at the conclusion of this year's Annual General Meeting.
